## Teacher Trustee to be Elected at Delegates Meeting

Delegates attending the 2025 Annual Delegates Meeting will elect one active teacher to NYSTRS' Board of Trustees. (For more about the meeting, see page 4.)



Natalie McKay

Only delegates, elected by their colleagues from NYSTRS-participating employers, are eligible to vote for the three active teacher members on the 10-member Board. Each teacher member serves a staggered three-year term.

Natalie McKay, a teacher in the Schoharie Central School District,

is running for election for the 2026-2029 term on the Board. She was appointed to the Board earlier this year by New York State Commissioner of Education Dr. Betty A. Rosa to fill the remainder of the term vacated by Juliet C. Benaquisto upon her retirement. McKay serves on the Board's Disability Review Committee.



McKay has taught in the Schoharie Central School District since 2005 and served as a teacher mentor since 2017. A NYSTRS delegate prior to joining the Board, she has served as president of the Schoharie Teachers Association since 2016 and served on its executive board since 2010.

She has represented her region as an at-large director on the NYSUT Board of Directors and is a graduate of the AFL-CIO/Cornell Union Leadership Institute.

McKay received a bachelor's degree in childhood education from the College of Saint Rose and a master's degree in educational policy and leadership from the University at Albany.

The other active teacher members on the Board are Eric J. Iberger of the Bayport-Blue Point Union Free School District and Donald A. Little III of the Syracuse City School District. Board President David P. Keefe of Hempstead is the retired teacher member elected by NYSTRS retirees.

Trustees serve without compensation and are responsible as fiduciaries to protect the long-term value of the System's investment portfolio to provide benefit security for members. They serve three-year terms, except the State Comptroller (or the Comptroller's designee), who serves while in office.

Nominations for other active teacher candidates to serve on the Board must be submitted by Oct. 3; only delegates may submit nominations.

#### **KEEP YOUR BENEFICIARIES UP TO DATE**

Accurate beneficiary designations ensure your wishes are followed and your loved ones are protected. When you receive your *Benefit Profile* each November, take a moment to confirm or update your designations. To make changes, create or log in to your <u>MyNYSTRS</u> account and visit My Retirement/Beneficiaries, or print, complete and mail a notarized <u>Designation of Beneficiary for In-Service or Post-Retirement Paragraph 2 Death Benefit</u> (NET-11.4) form.



#### **KNOW YOUR SERVICE MILESTONES**

Even early in your career, key service milestones help build your future. After one year of service credit, you're covered by an inservice death benefit. After two years, you may purchase prior service credit. With five years of credit, your pension is vested, or guaranteed. 

#### **Are You PREPared for Retirement?**

Many retirees wish they began focusing on financial and retirement planning much earlier in their lives. Our Pension & Retirement Education Program (PREP) is designed to help mid-career members prepare for retirement. Each session provides essential retirement planning tips and will help you understand your NYSTRS benefits.

#### **Delegates Meeting is Nov. 2-3**

NYSTRS' Annual Delegates Meeting will be held Sunday, Nov. 2 and Monday, Nov. 3 at the Saratoga Springs City Center. The two-day event includes educational seminars, a Delegate-Board/Staff Discussion, and the election of a teacher Board member (see related article on page 1).

Elected by peers at their district, delegates serve two important functions: to elect a teacher member to the Retirement Board at the Annual Delegates Meeting, and to serve as a liaison between NYSTRS and the members in their district. The meeting provides delegates a chance to learn more about NYSTRS and NYSTRS benefits, as well as meet other delegates and NYSTRS staff.

### Your Benefit Profile Arrives This November

This fall, make time for a one-on-one with your *Benefit Profile*. It provides a summary of your service credit and earnings – key factors of your retirement benefit formula. Depending on your membership status and eligibility, your *Profile* may also include projections of your service retirement benefit, disability and death benefits, your contributions summary, loan details (if applicable) and beneficiary designations.

Take a moment to ensure all records are current and accurate. You can update beneficiaries in <u>MyNYSTRS</u>. If you spot errors in your service or salary data, contact your employer(s) and ask them to send corrections to NYSTRS right away.

If you e-subscribe, you'll get an email in early November when your *Profile* is available in MyNYSTRS. If you chose a paper copy, it will be mailed by late November. Members who joined the System after June 30, 2025 will receive their first *Profile* in fall 2026.
